Climbing Jungle Liability and Waiver form

Terms and Conditions

Please read carefully

I am, or legal guardian is, age 18 years old or over and can be deemed legally competent to sign this agreement.

I understand that indoor rock climbing, bouldering and exercise involves risk which may cause various injuries that may result in death or serious disability.

I understand that indoor rock climbing is a physically demanding sport. People may experience panic attacks, hyperventilation, heart attack or other unwanted physical injury or mental trauma.

I wish to voluntarily participate in all activities provided at Climbing Jungle.

I understand all the risk of injury or bodily harm to myself and others participants.

I hereby and indemnify Climbing Jungle subsidiaries and associated bodies as defined under the Corporate Law ("Climbing Jungle"). its servant and agent, the owner of the premises and any other person involved in my participation in indoor climbing and any other activities at Climbing Jungle from all actions or claims for compensation arising from my participation for personal injury and or death or damage to property.

I agree this waiver is ongoing and will apply for all future occasions I participate in indoor climbing and any other activities at Climbing Jungle.

I acknowledge that this document is contractual and may be relied upon any proceeding by me, my heirs, executors and assigns and this waiver release and indemnity is given in consideration of Climbing Jungle permitting me to participate in indoor climbing any other activities at Climbing Jungle.

I agree to comply with all instructions given to me by climbing Jungle and Staff and the owner of the premises against all liability that may incur, including legal cost, caused by my negligence or failure to comply with such instructions. I will not conduct activities within the Climbing Jungle for which I am not certified. I warrant that I do not suffer from any medical condition and take any medications that may affect my ability to participate safely in strenuous exercise.

For the avoidance of doubt, the following are not permitted at our facility: Consumption of alcohol, tobacco or illegal substances.

Using our facility under the influence of any intoxicant.

Conduction business or paid services without our written consent. any use of facilities, or any equipment contained therein, other than for its ordinary purpose, and in accordance with Our instructions. any activities which we deem to constitute bullying, harassment or inappropriate behaviour, whether direct at our Staff or other users of our facility.

Our mission is to promote indoor climbing and any other activities at Climbing Jungle and therefore we always take pictures and videos at our premises and publish them through various marketing and other promotional purposes. I waive any rights and claims to any benefits in connection with the use of the images.

By signing this document I agree that I carefully read and fully understand the above Liability waiver Agreement.
